Fulcrum Acquisition Completed

14th January 2010

Aragon Resources Limited (ASX:AAG) ("Aragon") advises that following shareholder approval at a General Meeting held on Wednesday 30th December 2010 today it has allotted 35,000,000 fully paid ordinary shares in the capital of Aragon and 17,500,000 options over ordinary shares at the exercise price of \$0.20 per share on or before 31 December 2013 as consideration for the acquisition of 100% of Fulcrum Resources Pty Ltd ("Fulcrum"). See Appendix 3B attached.

As previously announced on the 3rd December 2009 and the 7th January 2010 Aragon has completed a capital raising of \$13 million that will be used to allow Fulcrum to complete the acquisition of the Cue Gold Project from Harmony/New Hampton which is in progress and to provide working capital to commence exploration and development activities.

Aragon expects to commence on ground exploration activities at the Cue Gold project as soon as practicable.
